
Today's OEL Processes

 - 2005 Control of Substances
 Hazardous to Health Regulations
 (COSHH)
 - **2007 REACH**

REACH

- EU effort
- 2007 Regulation on Registration
 Evaluation & Control of
 Chemicals
- Prescribed DNELs
- Include health, environmental and physical safety risks
- Lower than traditional OELs


OEL Global Challenges

- Number of chemicals in commerce
- OELs not well understood
- Emphasis--full cycle risks
- Not all value OELs
- Basic data--quality & reliability
- Resources and expertise

OEL Global Challenges


- Varied risk determination efforts, resulting exposure levels and protection levels
- Few direct measurement methods
- REACH--new playing field
- OELs not true threshold of toxic risk, but acceptable risk.


Various OELs for Manganese

- Purchase decisions
- Control recommendations for product consumers

Global Alternative

HARMONIZATION-Making identical or
minimizing differences
between standards or related
measures of similar scope

Reality #1

- Subjective Perception born of different Personal Values may doom HARMONIZATION.
- HARMONIZATION
 between different countries
 and cultures challenging.

Reality # 2

Common overarching value of protecting Human Health may allow for international SHARING of information documenting the exposure limits.

Reality #3

- Shared DATA will be critical to feeding the process.
- REACH may force sharing.
