

**24-7. Increase the proportion of persons with asthma who receive appropriate asthma care according to the NAEPP guidelines.**

**24-7f. Persons with asthma who receive assistance with assessing and reducing exposure to environmental risk factors in their home, school, and work environments.**

<b>Questions Used to Obtain the National Baseline Data</b>	From the 2002 National Health Interview Survey:  [NUMERATOR:] Assistance in environmental risk reduction For persons under 18 years of age: yes to all: <ul style="list-style-type: none"> <li>➤ <i>Has a doctor or other health professional EVER advised you to change things in - -'s home, school, or work to improve {his/her} asthma?</i></li> <li>➤ <i>Has a doctor or other health professional EVER told you that {fill S.C. name} had asthma?</i></li> </ul>

- *Does {fill S.C. name} still have asthma?*

For persons aged 18 years and older: yes to all:

- *Has a doctor or other health professional EVER advised you to change things in your home, school, or work to improve your asthma?*
- *Have you EVER been told by a doctor or other health professional that you had...asthma?*
- *Do you still have asthma?*

Number of persons who report having current asthma

For persons under 18 years of age, yes to both:

- *Has a doctor or other health professional EVER told you that {fill S.C. name} had asthma?*
- *Does {fill S.C. name} still have asthma?*

For persons aged 18 years and older, yes to both:

- *Have you EVER been told by a doctor or other health professional that you had...asthma?*
- *Do you still have asthma?*

**Expected Periodicity** Periodic.

**Comments** Persons are classified as having received assistance with assessing and reducing exposure to environmental risk factors in their home, school, and work environments if they responded “yes” to the questions listed above under Numerator.

There was a methodological change in the numerator and in the denominator from ‘ever’ asthma plus either an asthma attack or reporting still having asthma to ‘current’ asthma (yes to ‘ever asthma’ and yes to ‘still asthma’) to maintain consistency with the Council of State and Territorial Epidemiologists (CSTE) case definition for asthma. In 2001 the question ‘do you still have asthma?’ was added to the NHIS child and adult questionnaires.

Data were previously displayed only for persons who reported ‘ever asthma’ plus either an asthma attack or still having asthma. The original baseline of 42 percent was changed to 43 percent due to the change in methodology. The baseline year (2002) did not change. The target of 50 percent did not

change based on the original target setting methodology.

Data are age adjusted to the 2000 standard population using the age groups under 18 years, 18-44, 45-54, 55-64, 65-74 and 75 years and over. Age-adjusted rates are weighted sums of age-specific rates. For a discussion on age adjustment, see Part A, section 7.

Objective 24-7 moved from developmental to measurable during the Healthy People 2010 Midcourse Review. Data from the NHIS became available to monitor all six sub-objectives.

For some measures, data do not meet the criteria for statistical reliability, data quality, or confidentiality and have been suppressed. Information on suppression of data for the major Healthy People 2010 data systems has been published in a *Healthy People Statistical Note*<sup>1</sup>
