

Tip Sheet: Specialist Examination(s) – Referring Applicants

Apart from the commonly completed examinations in eMedical, applicants may be required to complete additional examinations (tests) as part of their visa application requirement. These are generally referred to as specialist examinations.


Note: If your clinic is not able to perform a specialist examination 'in-house', applicants must be referred to a clinic that offers the relevant services required to process the particular examination.

Note: If the referral process for a specialist examination is not completed then that examination will be greyed out and you will not be able to record and submit the required examination.

1.1. Referring Applicants


The first step of processing a specialist examination in eMedical is to refer the applicant. To do this:

Step 1. Open the test from the 'tree' on the left hand side of the screen and click **Refer Applicant**

1.2. No clinics to refer to
