

Tip Sheet: Automatically Generated Examination(s) and Health Case Classification

This tip sheet will help you to understand when additional examination(s) generated automatically for a U.S. Visa health case that you are processing.

Please note that additional examinations will not appear until the **“Prepare for classification”** button is pressed. This means that if you are entering details in eMedical after the applicant has left your clinic, a repeat examination may be generated and you will need to contact the applicant. It is recommended that where possible, the basic and detailed medical questions are completed *while the applicant is present* and the **“Prepare for classification”** button is pressed at this time, to avoid the need for repeat appointments.

When are additional health examinations generated for U.S. Visa health cases?

Examinations must be completed when generated:

U.S. Visa Health Cases and Classification

eMedical will auto-classify health cases in the following scenarios that you will not be able to change. Generally, the classifications are determined from the answers recorded in the examination(s), but a couple of classifications may be selected at the discretion of the panel physician. There are three categories of classification:

- The **Class A classification** specifies that the applicant has an inadmissible medical condition (communicable disease of public health significance, physical or mental disorder with associated harmful behavior, drug abuse or addiction), or does not have documentation of having received vaccinations against vaccine-preventable diseases.
- The **Class B classification** indicates that the applicant has a medical condition that is not an inadmissible condition, but represents a significant departure from normal health. The classifications are automatically determined from the answers on the exam(s), however, some classifications may be selected at the discretion of the panel physician.
- For a health case that is considered as not classified the **No apparent defect, disease or disability** is automatically selected.
- A health case may have more than one classification. However, it cannot be classified as both **Class B1TB**, nor as both **Class B3TB** and either **Class A** or **Class B1TB, Extrapulmonary**.
