

Fact Sheet Faculty and Staff Health Promotion

From CDC's School Health Policies and Programs Study (SHPPS) 2000

About SHPPS

SHPPS is a national survey periodically conducted to assess school health policies and programs at the state, district, school, and classroom levels. Results from SHPPS 2000 are published in the *Journal of School Health*, Volume 71, Number 7, September 2001.

- 20.0% of states, 28.2% of districts, and 29.5% of schools have a person who oversees or coordinates health promotion activities or services for school faculty and staff.
- 76.1% of schools make school physical activity facilities or equipment available for the school's faculty and staff to use.
