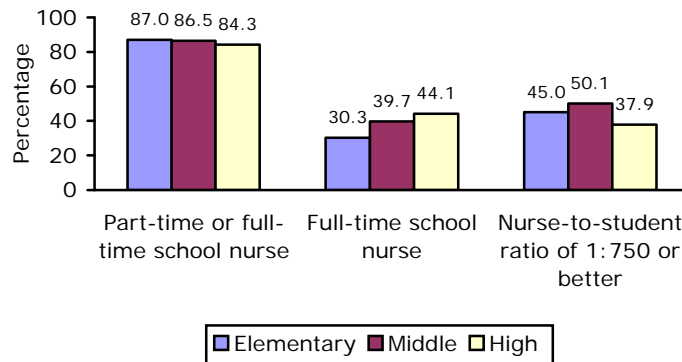


## Health Services

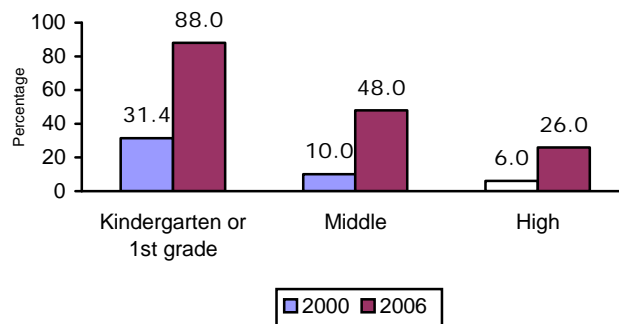
**About SHPPS:** SHPPS is a national survey periodically conducted to assess school health policies and programs at the state, district, school, and classroom levels. Comprehensive results from SHPPS 2006 are published in the *Journal of School Health*, Volume 77, Number 8, October 2007.

- 74.5% of states, 79.0% of districts, and 81.5% of schools had a person who oversees or coordinates health services.
- 86.4% of states, 11.1% of districts had at least one school-based health center that provided physical health services to students.
- 5.1% of elementary schools, 6.7% of middle schools, and 9.2% of high schools had at least one school-based health center that provided physical health services to students.
- 86.0% of states and 82.4% of districts required newly hired school nurses to have either a registered nurse's (RN's) license or a licensed practical nurse's (LPN's) license.
- 32.7% of states and 73.3% of districts required that supplies for applying standard or universal precautions, including disposable gloves and bandages, would be available in all classrooms.
- 5.8% of states and 19.5% of districts required each school to have at least one full-time school nurse, and 16.0% of states and 12.2% of districts required a maximum student-to-school nurse ratio.
- 34.1% of schools had arrangements with agencies, organizations, or health care providers not located on school property to provide health services to students when needed.

<sup>1</sup> Selected changes between 2000 and 2006 are included if they met at least 2 of 3 criteria ( $p < .01$  from a t-test, a difference greater than 10 percentage points, or an increase by at least a factor of 2 or decrease by at least half). Variables are not included if they do not meet these criteria or if no comparable variable existed in both survey years.

- 80.7% of schools screened students for hearing problems, 83.4% screened for vision problems, 29.4% screened for oral health problems, 44.0% screened for scoliosis, and 42.3% screened for height and weight or body mass problems.
- The percentage of schools in which health services staff were required to follow “do-not-resuscitate” (DNR) orders increased from 29.7% in 2000 to 46.2% in 2006.
