Comments Newly enacted State tobacco-control legislation is

downloaded from Lexis-Nexis, an on-line legal database. CDC, OSH searches two Lexis-Nexis subfiles: the StateTrack System and the Advanced Legislative Services System. The downloads are

coded according to variables identified by CDC, OSH, which include the comprehensiveness of the law, includes smoking areas permitted or required, separately ventilated smoking areas required, and no smoking allowed. In some cases, data on enforcement authority, penalty for violation, and signage required are also collected.

Retail stores, as a general category, are not tracked. Measures are only available for malls and grocery stores. Data on enforcement authority, penalty for violation, and signage required are not currently included in the STATE System for this objective.

The text of objective 27-13 was revised at the Healthy People 2010 Midcourse Review. The language about limiting smoking to "separately ventilated areas" was dropped. The rationale was that laws that prohibit smoking altogether in worksites better protect the health of workers.

The original baseline (4 States) was revised to 6 States to reflect the revised text. The target, 51 States, did not change.

The baseline was later revised from 6 to 1 after the data in the STATE System was updated as part of a quality assurance process. The target did not change.

Objective 27-13 was adapted from Healthy People 2000 objective 3.12, which monitored States with laws that prohibited smoking in workplaces and public places or limited it to separately ventilated areas. The Healthy People 2000 objective tracked 7 types of places: public workplaces, private workplaces, restaurants, public transportation, hospitals, day care centers, and grocery stores. In addition to these places, objective 27-13 monitors States that prohibit smoking in retain stores (rather than grocery stores) and bars, as well as laws enacted by Tribes and Territories.
