




# Foodborne infections: *Campylobacter jejuni*Healthy People 2000 objective 12.1





# Foodborne infections: *Escherichia coli* O157:H7 Healthy People 2000 objective 12.1





### Foodborne infections: *Listeria monocytogenes*Healthy People 2000 objective 12.1









#### Adoption of the FDA Food Code for retail establishments: Healthy People 2000 objective 12.4








