# **Technical Notes on Sampling Design**

The sample design of the 2007 National Home Health and Hospice Care Survey estimates the number of current home health patients at a given point in time and the number of hospice discharges in a year. This design requires the data user to always do separate analysis of patients and discharges, using the PHTYPE variable. For current home health patients, PHTYPE=1 and for annual hospice discharges, PHTYPE=2.

### **Technical Notes on Nesting and Weight Variables**

The design of the 2007 National Home Health and Hospice Care Survey entailed stratified sampling. The patient/discharge public-use file includes the nest variable of the sampling framework for use in statistical software that accounts for complex sample designs in the estimation of variances and standard errors. Proper adjustment of standard errors for stratified or clustered sampling provides the analyst with accurate significance tests.

The nest variables in the patient/discharge file are PSTRATA, PTAGYNUM, and PHTYPE.

In the statistical software, SUDAAN, the analyst can use the design option WOR for sampling without replacement. When using SUDAAN for WOR, the variables for the TOTCNT statement in SUDAAN are POPPAT, POPAGN, and \_ZERO\_. Below is the SUDAAN code for the NEST and TOTCNT statements for the patient/discharge public-use file with WOR. The first example uses the crosstab procedure to illustrate using the weight, SAMWT, for estimates of current home health patients (PHTYPE = 1). The second example uses the crosstab procedure to illustrate using the weight, SAMWT, for estimates of annual hospice discharges (PHTYPE = 2).

# **Technical Notes on Imputed Variables**

Note on cases with imputed age: The variable AGEIMP indicates cases where age was imputed. For each case in which age was imputed, similar cases in the sample with age known were selected with one randomly choosen from the group of similar cases. The known age of the selected case was then assigned to the case with age originally missing. The algorithm for selecting similar cases involved assessment of the match on the following characteristics: resident gender, length of stay, dependency on activities of daily living, facility ownership, bed size, region, and metropolitan status of the facility.

Note on cases with imputed race: The variable RACEIMP indicates cases where race was imputed. For each case in which race was imputed, similar cases in the sample with race known were selected with one randomly choosen from the group of similar cases. The known race of the selected case was then assigned to the case with race originally missing. The algorithm for selecting similar cases involved assessment of the match on the following characteristics: resident gender, marital status, ethnicity (Hispanic or Non-Hispanic), facility ownership, bed size, state (then region if state did not match), and metropolitan status of the facility.

# Technical Notes on Meaning of -1, -7, and -8 Values

The negative values, -1, -7, and -8, indicate different reasons for blank or missing values on numeric variables.

- -8 means the respondent was asked the question but answered that she/he did not know the answer ("DK").
- -7 means the respondent was asked the question but refused to give an answer ("RF").
- -1 was used for all other blank or missing data. -1 was used when the respondent did not answer a question either because the question was legitimately skipped ("inapplicable") or the respondent did not complete the question ("not ascertained"). An example of a skipped question is when a question was about home health and the respondent was a hospice discharge. Questions administered during the interview at the agency could be not ascertained because the interviewer never had an opportunity to ask the question, for example, because a respondent in the agency was not available to answer the specific question.

If a user desires to exclude all cases on a variable with blank or missing values, all negative values can be set to a statistical software package's default value for missing. For example, in SAS setting -1, -7, and -8 to missing on the variable, ANYADDIR, can be accomplished by the statement:

IF ANYADDIR It 0 then ANYADDIR = .;
