	Objective 8-27 was adapted from Healthy People 2000 objective 11.16; to establish and monitor State plans to define and track sentinel environmental diseases. The Healthy People 2000 objective tracked State data collection for 9 diseases including lead poisoning, mercury poisoning, arsenic poisoning, cadmium poisoning, methemoglobinemia, acute chemical poisoning, carbon monoxide poisoning, heatstroke, and hypothermia. Objective 8-27 tracks the monitoring of these diseases as well as 3 others: pesticide poisoning, asthma, and birth defects. The U.S. Territories and Tribes were added to the populations targeted by objective 8-27. Unlike the Healthy People 2000 objective, which had a single target of 35 States, the objective 8-27 targets are specific for each subobjective and range from 10 to 51 jurisdictions.
	An operational definition for number of Tribes and number of Territories was not available at the time of publication, and no proposed data source for Tribes and Territories has been identified, therefore, data for Tribes and Territories are developmental.
