Technical Notes on Nesting and Weight Variables The design of the 2007 National Home Health Aide Survey entailed stratified sampling. The home health aide public-use file includes the nest variable of the sampling framework for use in statistical software that accounts for complex sample designs in the estimation of variances and standard errors. Proper adjustment of standard errors for stratified or clustered sampling provides the analyst with accurate significance tests. The nest variables in the home health aide file are ASTRATA and HHAAGYID. In the statistical software, SUDAAN, the analyst can use the design option WOR for sampling without replacement. When using SUDAAN for WOR, the variables for the TOTCNT statements in SUDAAN are POPAGY and POPHHA. Below are the SUDAAN statements for the NEST and TOTCNT statements for the agency public $use \ file \ with \ WOR. \ The \ example \ below \ uses \ the \ crosstab \ procedure \ to \ illustrate \ using \ the \ weight, \ SAMWT, \ for \ estimates \ .$ proc crosstab data=[file name] design=WOR; nest ASTRATA HHAAGYID/ missunit; totent POPAGY POPHHA: weight SAMWT; **Technical Notes on Imputed Variables** Note on cases with imputed sex: The variable SEXIMP indicates cases where sex was imputed. For each case in which sex was imputed a random number between 0 and 100 was generated and sex assigned based on the distribution of sex in the known population in the sample. If the random number was at or below 96.9 (the percent of known cases that were female) then the unknown case was assigned the female value. If the random number was above 96.9 then the unknown case was assigned the male value. Note on cases with imputed age: The variable AGEIMP indicates cases where age was imputed. For each case in which age was imputed, a case from the sample with age known was randomly selected. The known age of the selected case was then assigned to the case with age originally missing. Note on cases with imputed race: The variable RACEIMP indicates cases where race was imputed. For each case in which race was imputed, similar cases in the sample with race known were selected with one randomly chosen from the group of similar cases. The known race of the selected case was then assigned to the case with race originally missing. The algorithm for selecting similar cases involved assessment of the match on the following characteristics: geographic locality and ethnicity. Note on Meaning of -1, -7, and -8 Values The negative values, -1, -7, and -8, indicate different reasons for blank or missing values on numeric variables. -8 means the respondent was asked the question but answered that she/he did not know the answer ("DK"). -7 means the respondent was asked the question but refused to give an answer ("RF"). -1 was used for all other blank or missing data. -1 was used when the respondent did not answer a question either because the question was legitimately skipped ("inapplicable") or the respondent did not complete the question ("not ascertained"). An example of a skipped question is Question J10 "What types of equipment or devices are needed to make their job better?". Aides were only asked this question if they responded Yes to J9 - Is there any other equipment needed to make your job safer". Aides who responded No to J9 would not be asked J10, and thus these aides had a value of -1 for all responses in J10. If a user desires to exclude all cases on a variable with blank or missing values, all negative values can be set to a statistical software package's default value for missing. For example, in SAS setting -1, -7, and -8 to missing on the variable, AGAINHHA, can be accomplished by the statement: IF AGAINHHA lt 0 then AGAINHHA = .; Frequency of Sampled Cases for Selected Variables Frequencies of selected variables at different locations in the file layout are reported below to assist the analyst in verifying the integrity of the data file and layout used.
