1-4. Increase the proportion of persons who have a specific source of ongoing care.

1-4b. Children and youth aged 17 years and under.

Comments

In 1998, a specific source of primary care included responses (a), (b), (d), and (e) listed above.

The survey question was modified slightly in 1999 when the response category “(f) Doesn’t go to one place most often” was added. Since 1999, the definition of a specific source of primary care includes responses (a), (b), (d), (e), and (f).

There have been no changes to the survey question since 1999.

Originally, this subobjective was measured using age-adjusted percents. The measure was revised to use crude percents after the Healthy People 2010 Midcourse Review. The baseline and tracking data have been recomputed in terms of crude percents.

The original baseline of 93 percent was revised to 94 percent as a result of the change from crude to age-adjusted rates mentioned above. The target (97 percent) did not change.

This subobjective is used to track the Access to Health Care Leading Health Indicator. See Appendix E for a complete list.

Objective 1-4 is similar to Healthy People 2000 objective 21.3, which tracked the proportion of persons aged 18 years and older with a specific source of ongoing care. Objective 1-4 tracks persons of all ages, through 3 subobjectives targeting all ages, persons aged 17 years and under, and persons aged 18 years and older.

For some measures, data do not meet the criteria for statistical reliability, data quality, or confidentiality and have been suppressed. Information on suppression of data for the major Healthy People 2010 data systems has been published in a *Healthy People Statistical Note*.¹
