The unadjusted productivity loss (in millions) has been published previously, based on estimates,

analyses, and data reported by NIAA earlier in the decade.²

The average Consumer Price Index (CPI) is made available by the Bureau of Labor Statistics each year.³ The Intercensal Estimates of the United States Resident population is made available by the Census Bureau.⁴

Objective 26-8 moved from developmental to measurable at the Healthy People 2010 Midcourse Review. Two subobjectives were created, the first addressing alcohol abuse and the second, substance abuse.
