

# 1995-1996 National Health Interview Survey (NHIS)

## Largest Consolidated Metropolitan Statistical Area (CMSA), Primary Metropolitan Statistical Area (PMSA) and Metropolitan Statistical Area (MSA) Recodes

The 1995 - 1996 MSA data files contain one record per household represented in the National Health Interview Survey Public Use files along with a recode of the thirty-three largest CMSA/PMSA/MSA's and selected subareas. Segments which are not within the identified areas will be blank in the recode field. These areas can be merged into the NHIS public use files for the data year by matching locations 1-10 of the attached file to locations 5-14 in the public use files. The attached file is sorted by locations 1-10. The format is as follows:
