CFA does not have specific activities or metrics focused on AI/AN. However, CFA is identifying disparities and building capacity to gather and analyze data with a focus on groups with highest risk of severe outcomes. CFA continues to prioritize and build upon equity into their work. Current actional steps are:

- Developing equity-informed data on transmission of various diseases, work that is critical to protecting people from disease outbreaks.
- Establishing and analytic response team within the Predict Division that will focus on specific populations in high-risk seetings for infectious disease, such as prisons; shelter; nursing homes and other congregate settings.
- Improving data collection methods, which will allow CFA to explore heterogeneity within racial groups in exposures and outcomes of infectious disease models.
- Using relevant demographic categories in models to identify inequities in projected disease impacts.
- Making it a principle, when analyses identifying disparities in the impact of a disease or condition across demographic groups, to investigate the causes of the disparity and potential solutions rather than stopping with identification.
