- D. **LICENSE.** Adobe hereby grants to Licensee a worldwide, nonexclusive, nontransferable license, during the term of this Agreement, to reproduce in the United States, or in other countries permitted by Adobe, and distribute Adobe Acrobat Reader 1.0 for UNIX and DOS and accompanying documentation (“Acrobat Reader”). This license grant is subject to the attached Terms and Conditions, which are a part of this Agreement.

Adobe Acrobat Reader 1.0 (UNIX and DOS) License and Reproduction Agreement Terms and Conditions

1. Terms

(a) Price. There is no license fee for the Acrobat Reader.

(b) Reports. Within forty-five (45) days of the end of each calendar quarter, Licensee agrees to provide Adobe with a written report stating the number of copies of Acrobat Readers produced and distributed by Licensee in such quarter.

2. Restrictions on Decompiling. LICENSEE AGREES NOT TO ALTER, REVERSE ENGINEER, TRANSLATE, DISASSEMBLE, DECOMPILE, OR OTHERWISE ATTEMPT TO DERIVE SOURCE CODE TO THE ADOBE PRODUCTS IN WHOLE OR IN PART. LICENSEE AGREES NOT TO ALTER ANY PDF FILES INCLUDED WITH COPIES OF THE ADOBE PRODUCTS DELIVERED HEREUNDER.

3. Licensee's Obligations

(a) Marketing. Licensee may include the "Acrobat™ Reader" and the Acrobat logo in its packaging, advertising and promotional materials for the Licensee Products, as more fully described in Section 4.

(b) Proprietary Notices. Each copy of Acrobat Reader and the documentation shall contain the same proprietary notices on the media and within the code which appear on the media and within the code of such software and documentation delivered by Adobe to Licensee and as otherwise reasonably required by Adobe. Licensee agrees that any promotional materials for Acrobat Reader will include all applicable copyright and trademark notices of Adobe.

(c) Restricted Rights. Licensee will (a) identify and license Acrobat Reader and the documentation in all proposals and agreements with the United States Government or any contractor therefore; and (b) legend or mark Acrobat Reader and the documentation provided pursuant to any agreement with the United States Government or any contractor therefore, as follows:

(i) For acquisition by or on behalf of civilian agencies, as necessary to obtain protection substantially equivalent to that afforded to restricted computer software and related documentation developed at private expense and which is existing computer software no part of which was developed with government funds and provided with Restricted Rights in accordance with subparagraphs (a) through (d) of the "Commercial Computer Software - Restricted Rights" clause at 48 C.F.R. 52.227-19 of the Federal Acquisition Regulations and its successors;

(ii) For acquisition by or on behalf of units of the Department of Defense ("DoD") as necessary to obtain protection substantially equivalent to that afforded to commercial computer software and related documentation developed at private expense and provided with Restricted Rights as defined in DoD FAR Supplement 48 C.F.R. 252.227- 7013(c)(1)(ii) and its successors in effect for all solicitations and resulting contracts issued on or after May 18, 1987.

(d) New Versions. Adobe may, in its sole discretion, modify Acrobat Reader and deliver modified copies to Licensee for distribution under the terms of this Agreement.

(e) Sublicensing. Licensee will ensure that each copy of Acrobat Reader distributed by Licensee will be accompanied by the appropriate End User License Agreement, included by Adobe with the Acrobat Reader in electronic form.

(f) End User Support. Nothing in this Agreement shall obligate Adobe to provide support to end users who obtain copies of Acrobat Reader produced by Licensee.

4. Trademark License

(a) Scope of License. Adobe hereby grants to Licensee, and Licensee accepts, a worldwide, nonexclusive, nontransferable, personal right to use (i) the trademark "Acrobat" with the term "Reader" and (ii) the Adobe Acrobat logo signature or any

substitute therefore (“Trademarks”), solely in conjunction with Licensee Products and in the manner described in Adobe’s Acrobat trademark signature guidelines, which shall be furnished to Licensee by Adobe.

(b) License Restrictions. All rights not expressly granted are reserved by Adobe. Licensee acknowledges that nothing in this Agreement shall give it any right, title or interest in the Trademarks, other than the license rights granted herein. Licensee may not use or reproduce the Trademarks in any manner other than as described in Adobe’s Acrobat signature guidelines or other applicable guidelines furnished to Licensee. Licensee shall not assign, transfer or sublicense this Agreement (or any right granted herein) without the prior written consent of Adobe.

(c) Criteria for Use; Inspection and Approval.

(i) Licensee may use the Trademarks only with Licensee Products that incorporate or include Acrobat Reader.

(ii) Licensee agrees to maintain the quality of Licensee Product(s) and Licensee Product upgrades used in conjunction with the Trademarks at a level that meets or exceeds industry standards and at least commensurate with the quality of products previously distributed by Licensee.

(iii) Upon reasonable notice from Adobe, Licensee shall supply Adobe with suitable specimens of the Licensee Product and Licensee’s use of the Trademarks in connection with the Licensee Product. Adobe may review Licensee’s use of the Trademarks periodically to evaluate Licensee’s compliance with the quality standards described in this Agreement.

(iv) Licensee shall remedy any deficiencies in its use of the Trademarks, conformance to the Adobe Acrobat compatibility criteria, and/or the quality of Licensee Product used in conjunction with the Trademarks, upon reasonable notice from Adobe.

(v) Licensee shall indemnify, defend, and hold harmless Adobe from and against any claims relating to the Licensee Product, including user claims regarding the Licensee Product’s incompatibility with the Acrobat Reader.

(d) Identification and Use.

(i) Licensee shall mark every initial or single use of the Trademarks with the symbol “TM” and shall include the following trademark attribution: *Acrobat and the Acrobat Logo are trademarks of Adobe Systems Incorporated which may be registered in certain jurisdictions.*

(ii) Licensee acknowledges Adobe’s ownership of the Trademarks. Licensee shall employ best efforts to use the Trademarks in a manner that does not derogate from Adobe’s rights in the Trademarks and will take no action that will interfere with or diminish Adobe’s rights in the Trademarks. Licensee agrees that all use of the Trademarks by Licensee will inure to the benefit of Adobe. Licensee may not use the Trademarks in any way as an endorsement or sponsorship of a Licensee Product by Adobe.

(e) Logo Representation. Adobe represents and warrants that use of the Trademarks in the United States does not infringe any United States trademark.

(f) Disclaimer. ADOBE MAKES NO OTHER WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, WITH RESPECT TO THE TRADEMARKS.

5. Proprietary Rights. Licensee acknowledges that the structure and organization of Acrobat Reader is proprietary to Adobe and that Adobe retains exclusive ownership of Acrobat Reader. Licensee will take all reasonable measures to protect Adobe’s proprietary rights in Acrobat Reader. Except as provided herein, Licensee is not granted any rights to patents, copyrights, trade secrets, trade names, trademarks (whether registered or unregistered), or any other rights, franchises or licenses with respect to Acrobat Reader. Nothing in this Agreement shall be construed as conferring any license or right under any patent.

6. No Warranty. The Acrobat Reader is being delivered to you AS IS and Adobe makes no warranty as to its use or performance. ADOBE AND ITS SUPPLIERS DO NOT AND CANNOT WARRANT THE PERFORMANCE OR RESULTS YOU MAY OBTAIN BY USING THE ACROBAT READER OR DOCUMENTATION. ADOBE AND ITS SUPPLIERS MAKE NO WARRANTIES, EXPRESS OR IMPLIED, AS TO NONINFRINGEMENT OF THIRD PARTY RIGHTS, MERCHANTABILITY, OR FITNESS FOR ANY PARTICULAR PURPOSE. NO

PERSON IS AUTHORIZED TO MAKE ANY WARRANTY OR REPRESENTATION CONCERNING THE PERFORMANCE OF THE ADOBE ADOBE READER. LICENSEE SHALL MAKE NO OTHER WARRANTY, EXPRESS OR IMPLIED, ON BEHALF OF ADOBE.

7. Term of Agreement. The date of execution of this Agreement by Adobe shall be the Effective Date of this Agreement. The term of this Agreement shall be for a period of three (3) years from the Effective Date and will automatically renew for successive one year terms unless either party gives the other party written notice that it will not renew the agreement at least thirty (30) days in advance of the renewal date. Adobe shall have the right to terminate this Agreement with or without cause upon thirty (30) days prior written notice. Upon termination or expiration of this Agreement, Licensee shall immediately discontinue distribution of Acrobat Reader and cease using the Trademarks. End users shall be permitted the continued and uninterrupted use of Acrobat Reader for the balance of the term of the End User License Agreement, provided that and so long as the end users are not in default of their End User License Agreements.

8. Consequential Damages Waiver. ADOBE WILL NOT BE LIABLE FOR ANY LOSS OF USE, INTERRUPTION OF BUSINESS, OR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY KIND (INCLUDING LOST PROFITS OR LOST SAVINGS) REGARDLESS OF THE FORM OF ACTION WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT PRODUCT LIABILITY OR OTHERWISE, EVEN IF ADOBE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

9. Notices. All notices under this Agreement shall be in writing and shall be deemed given if delivered personally, mailed by registered or certified mail, return receipt requested, or sent by facsimile with a receipt confirmed by telephone, to Licensee at the address set forth above, to Adobe as shown below, or to such other addresses as a party may from time to time notify the other party.

10. Entire Agreement; Amendment. Upon execution by both Adobe and Licensee, this Agreement, together with the End User License Agreement included with Acrobat Reader, contains the entire agreement of the parties with respect to the subject matter hereof, and shall supersede and merge all prior and contemporaneous communications. It shall not be amended except by a written agreement subsequent to the effective date and signed by authorized representatives of each party.

11. Miscellaneous. This Agreement shall be governed by and construed in accordance with the laws of the State of California. Licensee hereby consents to jurisdiction and venue in the state and federal courts sitting in the State of California. If either party employs attorneys to enforce any rights arising out of or related to this Agreement, the prevailing party shall be entitled to recover its reasonable attorneys' fees, costs, and other expenses.

Section headings are used herein for convenience of reference only and shall not affect the meaning of any provision of this Agreement. No waiver of any breach of any provision of this Agreement shall constitute a waiver of any prior, concurrent or subsequent breach of the same or any other provision hereof, and no waiver shall be effective unless made in writing and signed by an authorized representative of the waiving party. If any provision of this Agreement (or any other agreements incorporated herein) shall be held by a court of competent jurisdiction to be illegal, invalid or unenforceable, the remaining provisions shall remain in full force and effect. Nothing in this Agreement shall be construed as creating a partnership, joint venture or agency relationship or as granting a franchise.
