What is SLAITS?

SLAITS is a new population-based survey mechanism developed by CDC/NCHS to measure and monitor changes in health, health care, and wellbeing at state and local levels. This mechanism addresses state-specific needs for data using customized questionnaires and flexible sample selection. The SLAITS sampling frame is shared with the National Immunization Survey (NIS).

CSHCN Survey Objectives

- State-level prevalence estimates for CSHCN
- State-level needs assessment
- Healthy People 2010 baseline measurements
- State-level insurance estimates for <u>all</u> children

Survey Design

- Random-digit-dial telephone survey
- Computer-assisted telephone interviewing
- Screen all children under 18 years of age in the household for chronic conditions
- Detailed interview for one randomly selected child with special health care needs
- Brief health insurance interview for one randomly selected child without special needs
- Detailed interview about reasons for and impact of uninsurance for low-income children without health care coverage
- Statistical adjustments to account for households without telephones

Identifying Children with Special Health Care Needs: The Living With Illness Measure

- Need or use medicine prescribed by a doctor
- Need or use more medical care, mental health, or educations services that is usual for most children
- Limited or prevented in ability to do things
- Need or get special therapy
- Need or get treatment for an emotional, developmental, or behavioral problem

Questionnaire Content

- Health and functional status
- Health insurance and adequacy
- Access and utilization
- Care coordination
- Satisfaction with care
- Impact on families

Target Sample Sizes Per State

- Over 5,000 children in more than 2,750 households screened for special needs
- 750 detailed interviews for CSHCN
- 2,400 4,000 brief health insurance interviews
